EXECUTIVE DIRECTOR/ADMINISTRATOR:

AUDITOR AND ACTUARY YEAR-END REPORTS - Mr. Sacco referred to the Audit Report as of December 31, 2014 that was distributed to the Executive Board prior to the start of the meeting. He informed the Board that Mr. Jones from Nisivoccia and Company was present at the meeting to review the Audit Report. Mr. Jones began by reviewing the Operating Information which included Statement of Revenue, Expenses and Changes in Net Position breakdown contained within the audit report. He indicated that the Fund is in excellent financial condition as of the end of 2014. Mr. Jones then referred to the Auditors' Management Report which was also distributed to the Executive Board prior to the start of the meeting. He indicated that there are no recommendations. Following Mr. Jones' presentation, Mr. Sacco requested a motion to adopt the Resolution certifying the 2014 Audit and indicated that the Group Affidavit had to be executed..

MOTION TO APPROVE YEAR-END FINANCIALS, ADOPT RESOLUTION # 19-15 AND EXECUTE GROUP AFFIDAVIT INDICATING THAT MEMBERS OF THE EXECUTIVE COMMITTEE HAVE READ THE GENERAL COMMENTS SECTION OF THE AUDIT REPORT.

ACTUARIAL IBNR ESTIMATES – Mr. Sacco indicated that the EJIF's Actuarial IBNR Estimates valued as of March 31, 2015 was enclosed within the agenda booklet. He noted that the Fund's actuary, Mr. Kullmann of Aon was present and asked him to give a brief report. Mr. Kullmann reported that the results of the Actuarial valuation report were consistent with what was expected. He added that the total IBNR estimate of approximately 5.3 million which is unchanged from the prior year.

2015 BILLINGS- Mr. Sacco informed the Board that the second installment billings will be distributed to the membership next month.

NEXT MEETING- Mr. Sacco noted that the next meeting of the EJIF is scheduled for September 2, 2015 at the Forsgate CC, Jamesburg.

NEW POLICY FORM – Mr. Sacco informed the Board that the new policy form is continuing to be revised and asked Mr. Kickham to provide an update. Mr. Kickham advised that the main issues that the professional are having with the new policy form surround providing equal or better coverage without exposing the EJIF to a stacking of limits between coverage parts. He indicated that the professionals believe that they are close to a final document. Mr. Kickham added that the JIFs will be distributing their Member Manuals without the policy form and it is projected that the policy will be issued separately by the September meeting.

FINANCIAL FAST TRACK – Mr. Sacco referred to Financial Fast Track enclosed within the agenda booklet. He informed the Committee of the Fund's statutory surplus position as of March 31, 2015.

UNDERWRITING MANAGERS:

Mr. Casagrande informed the Board that a discussion took place amongst the professionals with respect to the EJIF website and Environmental Alerts. He noted that there is valuable information on the website and added that the alerts and website will continue to be improved.

Mr. Erickson reported that he attended the AWWA Conference and advised that a number of members are looking into new technologies. He added that these new technologies emphasize renewable energy and resource recovery.

Mr. Gulics reported that DEP has proposed changes to the underground storage tank rules and advised that those changes are being tracked. He added that once the changes are adopted the underground storage tank policies for underground piping.

Resolution of Certification Annual Audit Report for Period Ending December 31, 2014

WHEREAS, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions, and

WHEREAS, the Annual Report of Audit for the year 2014 has been filed by the appointed Fund Auditor with the Secretary of the Fund as per the requirements of N.J.S.A. 40A:5-6 and N.J.S.A. 40A:10-36, and a copy has been received by each Fund Commissioner, and

WHEREAS, the Local Finance Board of the State of New Jersey is authorized to prescribe reports pertaining to the local fiscal affairs, as per R.S. 52:27BB-34, and

WHEREAS, the Local Finance Board has promulgated a regulation requiring that the Fund Commissioners of the Fund shall, by resolution, certify to the Local Finance Board of the State of New Jersey that all Fund Commissioners have reviewed, as a minimum, the sections of the annual audit entitled:

General Comments and Recommendations

and

WHEREAS, the Fund Commissioners have personally reviewed, as a minimum, the Annual Report of Audit, and specifically the sections of the Annual Audit entitled:

General Comments and Recommendations

as evidenced by the group affidavit form of the Fund Commissioners.

WHEREAS, such resolution of certification shall be adopted by the Fund Commissioners no later than forty-five days after the receipt of the annual audit, as per the regulations of the Local Finance Board, and

WHEREAS, all Fund Commissioners have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of

New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the Fund Commissioners to the penalty provisions of R.S. 52:27BB-52 - to wit:

R.S. 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

NOW, THEREFORE, BE IT RESOLVED, that the Fund Commissioners of the New Jersey Municipal Environmental Risk Management Fund, hereby state that they have complied with the promulgation of the Local Finance Board of the State of New Jersey, dated July 30, 1968, and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.
