EXECUTIVE DIRECTOR/ADMINISTRATOR:

AUDITOR AND ACTUARY YEAR-END REPORTS - Mr. Kickham referred to the Audit Report as of December 31, 2015 that was distributed to the Executive Board prior to the start of the meeting. He informed the Board that Mr. Jones from Nisivoccia and Company was present at the meeting to review the Audit Report. Mr. Jones began by reviewing the Statement of Revenue, Expenses and Changes in Net Position breakdown contained within the audit report. He informed the Board that the Fund has just over \$15 million in Net Position and is excellent financial condition as of the end of 2015. Mr. Jones then referred to the Auditors' Management Report which was also distributed to the Executive Board prior to the start of the meeting. He indicated that there were no findings or recommendations. Following Mr. Jones' presentation, Mr. Kickham requested a motion to adopt the Resolution certifying the 2015 Audit and indicated that the Group Affidavit had to be executed.

MOTION TO APPROVE YEAR-END FINANCIALS, ADOPT RESOLUTION #18-16 AND EXECUTE GROUP AFFIDAVIT INDICATING THAT MEMBERS OF THE EXECUTIVE COMMITTEE HAVE READ THE GENERAL COMMENTS SECTION OF THE AUDIT REPORT.

ROLL CALL VOTE: Unanimous

ACTUARIAL IBNR ESTIMATES – Mr. Kickham indicated that the EJIF's Actuarial IBNR Estimates valued as of March 31, 2016 was enclosed within the agenda booklet. He noted that the Fund's actuary, Mr. Kullmann of Aon was present and asked him to give a brief report. Mr. Kullmann reported that the estimated IBNR as of March 31st was 6 million and noted that it was a decrease of \$450,000 from 3 months prior. He advised that the main reason for the decrease is a result of favorable performance in the previous Fund Year. He added that over the past 12 months, each quarter there has been approximately 200,000 received in reported loss and, as a result, the Ultimate Loss has decreased by approximately 1.1 million. Mr. Kullman further added that the Fund's experience has been reasonably stable and favorable relative the funding amounts.

2016 BILLINGS- Mr. Kickham advised that the first assessment installment was sent to our member JIF's in January and informed the Board that the second installment billings will be distributed during the next month.

NEXT MEETING- Mr. Kickham informed the Board that the next meeting of the EJIF is scheduled for September 7, 2016 at the Forsgate CC, Jamesburg.

FINANCIAL FAST TRACK – Mr. Kickham referred to the Year-end Financial Fast Track enclosed within the agenda booklet. He informed the Committee that as of March 31st the Fund's statutory surplus was \$16.1 million.

ATTORNEY:

Mr. Semrau indicated that his report was for closed session only.

UNDERWRITING MANAGERS:

COVERAGE

Mr. Casagrande reported that the Storage Tank Policy Form is in the process of being revised. He noted that the changes are mostly editorial.

Mr. Casagrande also reported that the NJUA has requested the EJIF consider providing coverage for the transport of sludge. He noted that there are approximately six member authorities that transport sludge, while 50 members have a vicarious exposure through contract with vendors to remove sludge. Mr. Casagrande indicated that no decision has been made in terms of coverage but advised that the NJUA Coverage Committee will meet again to discuss further and he would advise the Board accordingly.

ENVIRONMENTAL ENGINEERING:

Mr. Gulics reported that there are federal changes that have been made to UST requirements which the DEP will have to comply with. He advised that as the changes develop bulletins will be released to the membership and seminars will be scheduled.

Mr. Gulics advised the Board that updates are being made to the municipal inspection checklists. He indicted that point deductions on certain items will be increased to shed light on changes that members will need to focus on. He added that changes will be reviewed by a subcommittee prior to being implemented.

Mr. Erickson reported that DEP has been doing an outreach for the Storm-water pre-draft permit. He informed the Board that DEP has selected a number of municipalities to sit down with and fully audit, with Bogota being one of them. He noted that he will be in attendance at the meeting. Commissioner Tomasko thanked Mr. Erickson for recently attending a Mayor's breakfast in Bergen County. He noted that Mr. Erickson took the time to help various Elected Officials better understand the storm-water draft requirements and what the E-JIF's overall mission is.

Lastly, Mr. Sacco informed the Board that the Fund Office has seen an increase from the membership with regards to property acquisitions. He advised that the Environmental Engineers are preparing an updated foreclosed property bulletin. Mr. Gulics added that the bulletin is being updated and will be released to the membership in the near future.

Resolution of Certification Annual Audit Report for Period Ending December 31, 2015

WHEREAS, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions, and

WHEREAS, the Annual Report of Audit for the year 2015 has been filed by the appointed Fund Auditor with the Secretary of the Fund as per the requirements of N.J.S.A. 40A:5-6 and N.J.S.A. 40A:10-36, and a copy has been received by each Fund Commissioner, and

WHEREAS, the Local Finance Board of the State of New Jersey is authorized to prescribe reports pertaining to the local fiscal affairs, as per R.S. 52:27BB-34, and

WHEREAS, the Local Finance Board has promulgated a regulation requiring that the Fund Commissioners of the Fund shall, by resolution, certify to the Local Finance Board of the State of New Jersey that all Fund Commissioners have reviewed, as a minimum, the sections of the annual audit entitled:

General Comments and Recommendations

and

WHEREAS, the Fund Commissioners have personally reviewed, as a minimum, the Annual Report of Audit, and specifically the sections of the Annual Audit entitled:

General Comments and Recommendations

as evidenced by the group affidavit form of the Fund Commissioners.

WHEREAS, such resolution of certification shall be adopted by the Fund Commissioners no later than forty-five days after the receipt of the annual audit, as per the regulations of the Local Finance Board, and

WHEREAS, all Fund Commissioners have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of

New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the Fund Commissioners to the penalty provisions of R.S. 52:27BB-52 - to wit:

R.S. 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

NOW, THEREFORE, BE IT RESOLVED, that the Fund Commissioners of the New Jersey Municipal Environmental Risk Management Fund, hereby state that they have complied with the promulgation of the Local Finance Board of the State of New Jersey, dated July 30, 1968, and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.
