EXECUTIVE DIRECTOR/ADMINISTRATOR:

ACTUARIAL IBNR REPORT- Mr. Kickham referred to the actuarial IBNR estimates valued as of December 31, 2012 contained within the Agenda booklet. He asked that Mr. Kullman give a brief verbal report to the Committee. Mr. Kullman indicated that there were not many changes between the 2011 and 2012 reports. He added the corresponding ultimate loss changed by less than 200,000.

TPA - In light of on going discussion with the Fund's current TPA, the Executive Director is in the process of finalizing an RFP for TPA services. Mr. Kickham advised that Mr. King will stay in the position until his successor is appointed and will remain an active member of the Fund's defense team. He added that Mr. King has done a good job as the Fund's TPA but it is time that the Fund moves to a more structured approach in regards to third party adjusting. He referred the Committee to the sample RFP criteria enclosed in the Agenda booklet. Mr. Kickham indicated that the RFP will seek specialist in this area.

MOTION TO AUTHORIZE THE RELEASE OF AN RFP FOR THE POSITION OF TPA FOR THE EJIF USING THE CRITERIA PREVIOUSLY ESTABLISHED AND ADOPTED BY THE EJIF IN THE ISSUANCE OF PREVIOUS RFP'S

ENVIRONMENTAL ENGINEER'S 2013 CONTRACT - After careful review and discussions with the Fund's Executive Director, our Environmental Engineer has agreed to revisit their annual contract. Mr. Kickham informed the Committee that the contract is on a hourly basis with a not to exceed amount. Since the Fund has been in operation for 20 years, the Executive Director felt that some of the services performed by BSG could be consolidated and in some cases eliminated (i.e. multiple seminars). After discussions with BSG, it was agreed that \$50,000 would be removed from their not to exceed number and moved into general contingency.

REVISED BUDGET- Upon conclusion of the Environmental Engineer 2013 Contract discussion, Mr. Kickham referred the Board to the revised 2013 budget enclosed in the agenda. Mr. Sacco indicated that the Budget revisions reflect new members added to the local JIF's for 2013 as well as the Environmental Engineer's reduction in their not to exceed budgeted number. The contract reduction of \$50,000 was moved into the 2013 Budget's contingency line item.

MOTION TO APPROVE THE REVISIONS TO THE 2013 BUDGET TO REFLECT THE CHANGES IN MEMBERSHIP AND THE CONTRACT REDUCTION FOR BSG.

NJ SPOTLIGHT – Mr. Kickham referred to the article issued via internet news on January 23, 2013 enclosed in the Agenda booklet. The article is in regards to a bill which would end towns' liability for superfund site cleanup which environmentalists and business interests are united in lobbying against Bill A-3128. Mr. Kickham advised that Mr. Hagan, from PPAG is working with the Executive Directors and Fund Attorneys on ways to get the legislation passed.

NEXT MEETING- Mr. Sacco advised that due to the PRIMA Conference, the next meeting of the EJIF is scheduled for **Thursday**, **June 6**, **2013** at the Forsgate CC, Jamesburg.

ATTORNEY:

UNDERWRITING MANAGERS:

COVERAGE – Mr. Casagrande reminded the Committee that the deadline for the AST's associated with UGP testing reimbursement program is July 1, 2013. He added that approximately a dozen members have responded to the program.

UST BULLETIN – Mr. Casagrande once again informed the Committee that the E-JIF issues an annual bulletin reminding members that the Fund will no longer cover 20+ year old unregulated underground tanks after January 1, 2014. He reminded the Board that 2013 will be the last year that the Fund will cover these tanks. The bulletin will be mailed to members in the upcoming week.

TOMS RIVER PROPERTY – Mr. Casagrande advised that he spoke with Commissioner Shives in regards to the Lagoon Ave property. On the advice of the Commissioner, the Fund will wait until the Summer to possibly list the property, depending on the market. He added that the Fund Attorney may have to advertise as the property is owned by a public entity.

With nothing further, Mr. Casagrande concluded his report.

ENVIRONMENTAL ENGINEERING:

RECYCLING - Mr. Erickson advised the Committee of a new State mandate requiring each town to appoint a Certified Recycling Professional (CRP). He added that if a member needed more information regarding the CRP, contact him.

RECEPTOR EVALUATIONS – Mr. Erickson stated that member towns may have received letters from the NJDEP regarding contaminated sites. The deadline for completing Receptor Evaluations was March 1, 2012 and the deadline for retaining a Licensed Site Remediation Professional is May 7, 2012. He advised that if property in a member town has a NJDEP case number, a PI number, or has a confirmed discharge, the deadlines are applicable to your site. Mr. Erickson added that failure to comply with the deadlines may result in your project with the NJDEP potentially being audited and fined.
