EXECUTIVE DIRECTOR/ADMINISTRATOR:

REGULATORY AFFAIRS – Mr. Sacco informed the Board that the Fund Office filed the 2012 Year End Audit, Certification of the Audit adopted by the Executive Committee, Actuarial Valuation and Actuarial Certification with the Department of Banking and Insurance. In addition, the Synopsis of Audit was published in the Fund's newspaper.

2014 BUDGET PROCESS – Mr. Sacco referred the Committee to the 2014 draft budget workshop agenda enclosed within the agenda booklet and gave an overview. He noted that the Finance committee met via teleconference on September 3, 2013 to discuss the proposed 2014 budget and dividend recommendation. Mr. Sacco added that there is going to be an overall increase of 2.0% for the 2014 Budget. After review, it was the recommendation of the Finance Committee to approve the proposed budget.

MOTION TO INTRODUCE THE 2014 BUDGET FOR THE NEW JERSEY ENVIRONMENTAL RISK MANAGEMENT FUND IN THE AMOUNT OF \$4,221,803 AND SCHEDULE A PUBLIC HEARING FOR OCTOBER 16, 2013 AT THE FORSGATE CC, JAMESBURG, NJ AT 10:50 AM.

2013 DIVIDEND - Mr. Sacco advised that the Finance Committee also met via teleconference to review possible dividend disbursement. After a discussion, the Finance Committee recommends a dividend of \$450,000.

RFQ RESULTS- Mr. Kickham indicated that The EJIF received seven (7) responses to its published RFQ for the position of Environmental Engineer. Commissioner Cevetello, Chairman of the Rules and Contracts

committee, informed the Board that the sub committee met to review the submissions received and conducted interviews for the position of Environmental Engineer.

Mr. Kickham advised that after an extensive review process, the Rules and Contracts committee is recommending the EJIF enter into contracts with both T & M Associates and First Environmental. He noted that the service of the membership will be divided between the two firms by geographical location of each JIF. He advised that hiring the 2 firms will help streamline the process and make it more efficient. Mr. Kickham added that the sub-committee is also recommending that the other 5 respondents be placed on an approved list and their services will be utilized when the Fund requires a LSRP. He noted that since the other 5 respondents have already gone through the RFQ process, there would be no issues in retaining their services on an as needed basis. Commissioner Cevetello thanked his fellow sub-committee members as well as Mr. Kickham, Mr. Sacco, and Mr. Thorpe for their hard work throughout the review process.

MOTION TO APPOINT T & M ASSOCIATES AND FIRST ENVIRONMENT AS THE EJIF'S ENVIRONMENTAL CONSULTANTS AND TO APPROVE BOSWELL ENGINEERING, TETRA TECH, FRENCH & PARRELLO, BRILLIANT ENVIRONMENTAL SERVICES AND REMINGTON & VERNICK ON AN AS NEEDED BASIS FOR CASES THAT REQUIRE A LRSP

SENATE TESTIMONIAL- Mr. Kickham referred to Fund Commissioner Thomas Duch's Senate testimonial enclosed within the agenda booklet. He noted that he had a chance to hear Commissioner Duch's testimonial and indicated that he did an excellent job at the June 13, 2013 Senate Hearing.

PPAG REPORT- Mr. Kickham informed the Board that he had a report from Mr. Hagan of PPAG. He indicated that the Fund is out of the first committee for both the Senate and the Assembly on Bill 2094 and A3128. He advised that there is great opposition from the chemical industry and the environmentalists but noted that Mr. Hagan is still pushing ahead. Mr. Kickham reminded the Board that this is in regards to the Passaic River litigation and the attempt of redefining waste water and storm water into the Spill Fund.

NJ DEP NOTICE- Mr. Kickham referred to the public notice from the Department of Environmental Protection enclosed within the agenda booklet. He indicated that the notice was published in the Monday, July 1, 2013, New Jersey Register and pertains to the settlement of the Passaic River litigation. Mr. Kickham advised that effectively the members will have to pay \$95,000 to be released out of that litigation. He noted that \$50,000 will come from the EJIF and the excess \$45,000 will be delayed payment by the State. He also noted that the Fund is attempting to recover money from the previous insurers.

UNDERWRITING MANAGERS:

UGP ASSOCIATED WITH ASTs – Mr. Casagrande indicated that the compliance date deadline of July 1, 2013 passed. He informed the Board that there was less than 50% compliance and referred to the reminder notice that was sent to effected members who have lost coverage on those underground pipes. The reminder notice indicated that members have the ability to reinstate coverage and one-time reimbursement of testing expenses up to \$400 per test.

UST BULLETIN – Mr. Casagrande once again informed the Committee that the E-JIF issued its annual bulletin reminding members that the Fund will no longer cover 20+ year old unregulated underground tanks after January 1, 2014. He reminded the Board that 2013 will be the last year that the Fund will cover these tanks. Mr. Casagrande added that the bulletin was mailed all members in February.

POLICY REWRITE – Mr. Casagrande indicated that the Policy Rewrite has started again. He advised that there is an extensive review process and indicated that updates will be given.

With nothing further, Mr. Casagrande concluded his report.

ACTUARY:

Mr. Kullman informed the Board that his firm has completed the 2014 budget analysis and referred to the results enclosed within the agenda booklet. He advised that as part of their analysis, they reviewed updated exposures by member entity, reviewed the June 30th loss data, and incorporated the 2010 census data according to 3 year transition plan that is in place.

RESOLUTION NO. 22-13

RESOLUTION OF THE EXECUTIVE COMMITTEE OF THE NEW JERSEY ENVIRONMENTAL RISK MANAGEMENT FUND AUTHORIZING REFUND OF THE 2000 FUND YEAR SURPLUS ACCOUNTS.

WHEREAS, N.J.A.C. 11:15-2.21 provides that a FUND may seek approval from the Commissioner of Insurance for a refund of excess monies from any FUND year upon compliance with certain requirements; and

WHEREAS, the FUND has obtained a calculation from its Actuary and Executive Director as to the amount of money which is available for distribution consistent with the aforementioned regulations, and the financial integrity of the FUND; and

WHEREAS, the Executive Committee has determined that it would be in the best interest of the FUND and its member municipalities to make certain refunds;

NOW, THEREFORE, BE IT RESOLVED by the Executive Committee of the **New Jersey Environmental Risk Management**, As Follows:

- 1. Section B of N.J.A.C. 11:15-2.21 provides that the FUND may seek approval for refunds from funds other than those specified for Legal Liability, Defense or Environmental Services.
- 2. The Executive Committee has balanced the interests of the members in obtaining the benefit of such monies as are available for refund against the need for the FUND to protect and preserve its financial integrity. It is the conclusion of the Executive Committee that \$450,000 can be refunded from the 2000 Fund year surplus accounts. Therefore, the total amount to be returned to the E-JIF members will be \$450,000.
- 3. The Executive Director is, therefore, authorized and directed to submit such documents as the regulations require to the Department of Insurance and the Department of Community Affairs for the approval of the refunds in the amounts set forth above.
- 4. This authorization is based upon the Auditor's Report of the Historical Operating Results as of December 31, 2012. The aforementioned refund monies shall be allocated, as required and necessary, from the Fund years mentioned above.
- 5. The FUND Treasurer is authorized to prepare and execute checks for the pro-rated amount of the aforementioned refunds due to each member for the years in question, provided, however, the FUND Treasurer shall deduct the amount owed by the member local unit for any outstanding balances without regard for Fund year, upon receipt of written documentation of approval or acquiescence of these refunds from the Department of Insurance and the Department of Community Affairs. Said refunds shall be made to the municipalities which were members of the

FUND for the years in question in the same ratio as said municipalities were assessed for the years in question.
